#If applied in Sem 3 within 15 Days after Batch Wise Second Semester Exam are over	Refund on Sem 3, 4, 5, 6
#If applied in Sem 4 within 15 Days after Batch Wise Third Semester Exam are over	Refund on Sem 4, 5, 6
#If applied in Sem 5 within 15 Days after Batch Wise Fourth Semester Exam are over	Refund on Sem 5, 6
